

Terms of Service for Accessly.eu

Version dated: April 3, 2025

1. General Information

1.1. These Terms of Service govern the use of Accessly - a plugin enhancing website accessibility.

1.2. The service provider is Globe Group S.A., headquartered at Św. Marcin 69, 61-808 Poznań, Poland, VAT ID: 7811907312, email: hello@g-group.dev.

1.3. Installing the plugin signifies acceptance of these Terms.

2. Service Description

2.1. Accessly is a plugin installed on the Client's website by adding a single line of JavaScript code.

2.2. The plugin provides features that support website accessibility but does not guarantee full compliance with WCAG 2.1 requirements.

2.3. Accessly is an auxiliary solution and does not replace an accessibility audit or individual adjustments.

3. Plugin Features

Text Adjustments:

- Font size regulation (3 levels of enlargement)
- Letter spacing adjustment
- Line height regulation
- Font weight enhancement

Visual Modifications:

- Page contrast (color inversion, black-and-white mode, high contrast)

- Highlighting headings
- Enlarged cursor
- Animation disabling (for individuals with epilepsy)

Navigation Aids:

- Tab key navigation
- Text reader (speech synthesizer reading content)

AI Support:

- Automatic generation of alternative text (alt) for images
- Automatic creation of page description

4. Technical Requirements

4.1. The plugin requires adding JavaScript code to the Client's website.

4.2. The plugin operates on most popular browsers and operating systems.

4.3. The Service Provider is not responsible for incompatibility resulting from non-standard solutions used on the Client's website.

5. Billing and Payments

5.1. The Client can choose one of two payment models:

a) One-time payment – for perpetual use of the plugin in the selected version,

b) Subscription payment – annual fee according to the current price list available at www.accessly.eu.

5.2. In the case of a one-time payment, the Client additionally bears the costs of using AI-based functions, which depend on the number of users and the intensity of plugin usage. Billing details are presented individually.

5.3. In the subscription model, the price includes a specified limit of AI function usage according to the selected package.

5.4. Non-payment results in the automatic suspension of the plugin's operation after the subscription period expires.

6. Liability

6.1. The Service Provider strives to ensure the plugin operates correctly but does not guarantee its uninterrupted availability or full compliance of the Client's website with legal regulations.

6.2. The Client bears full responsibility for the content and structure of their website.

7. Final Provisions

7.1. The Service Provider reserves the right to make changes to the Terms. Changes are effective upon publication on accessly.eu.

7.2. Matters not regulated by these Terms are subject to Polish law.

7.3. Disputes arising from the use of the service will be resolved by the court competent for the Service Provider's headquarters.
